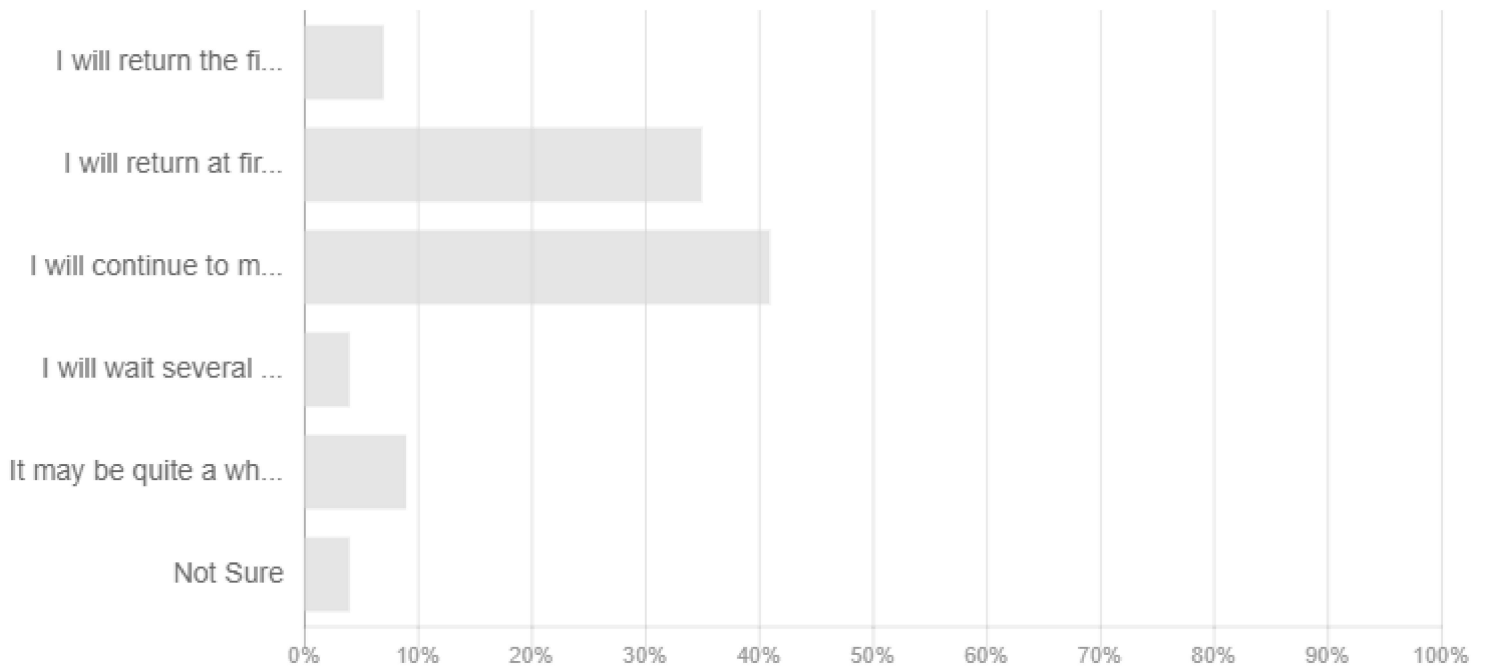

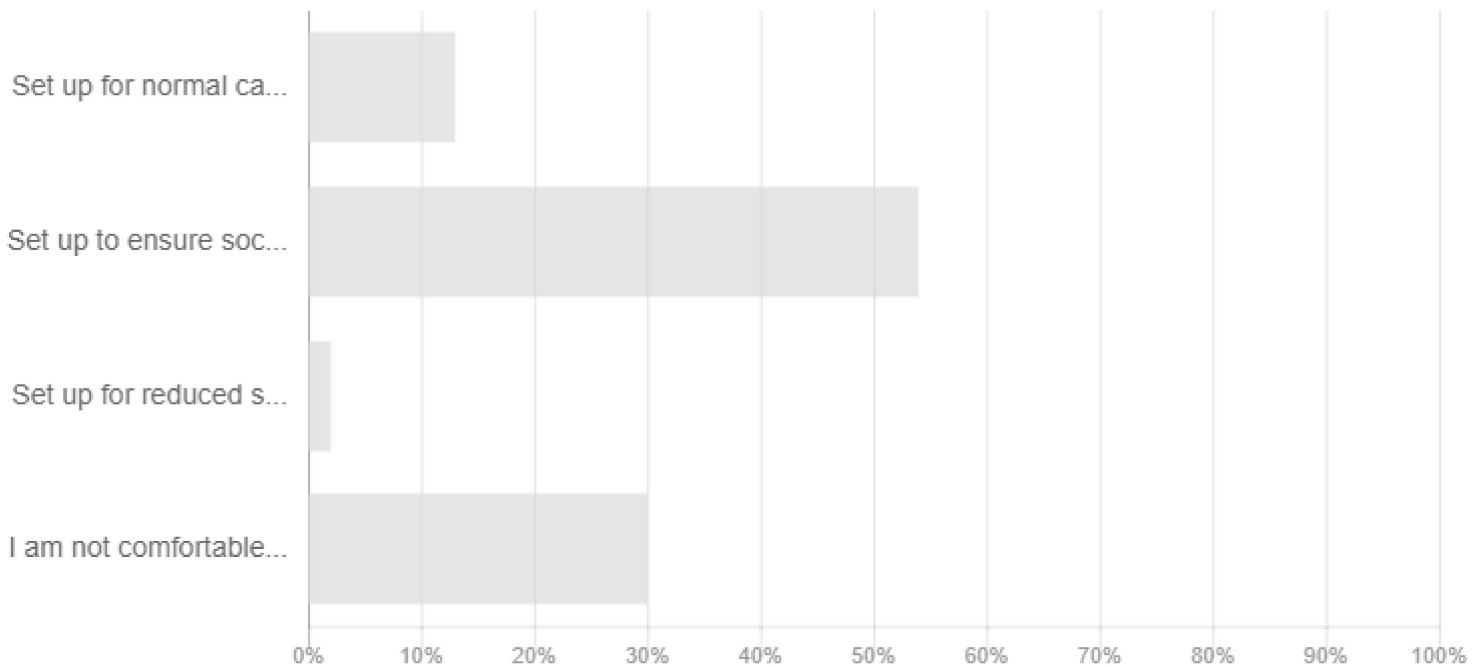

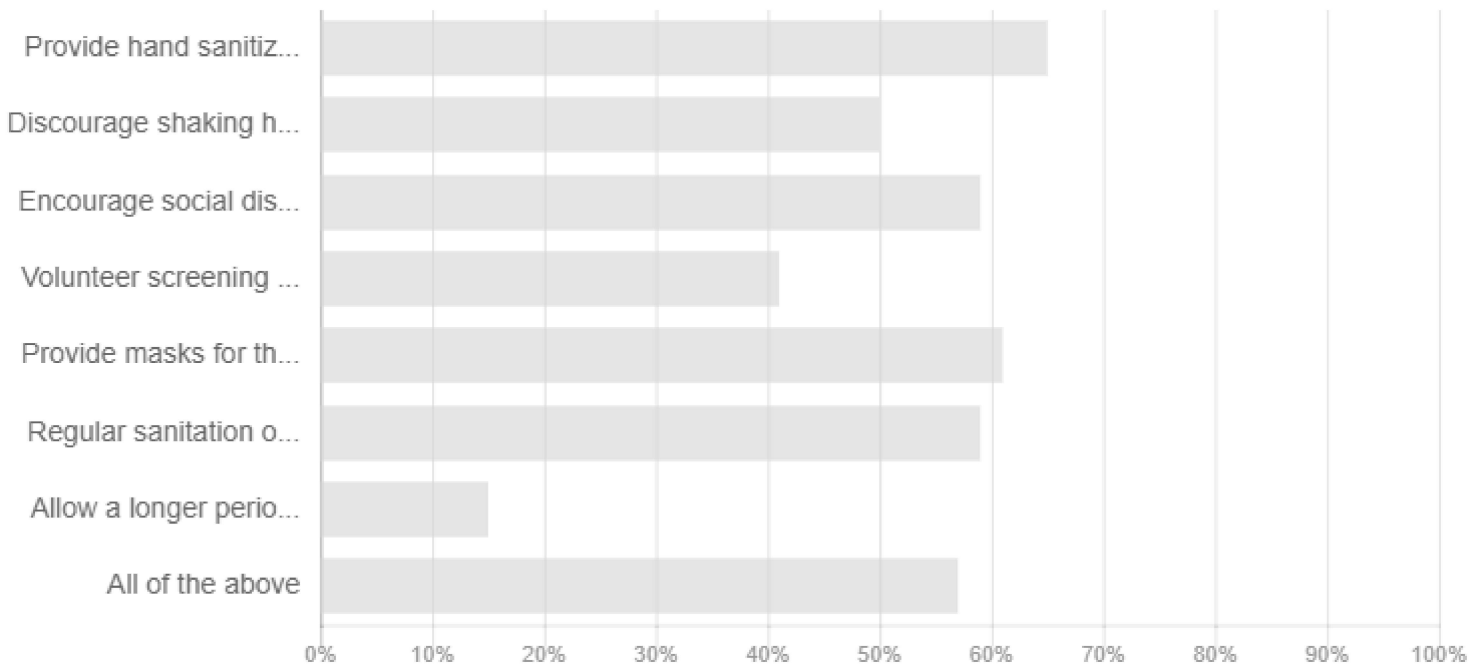

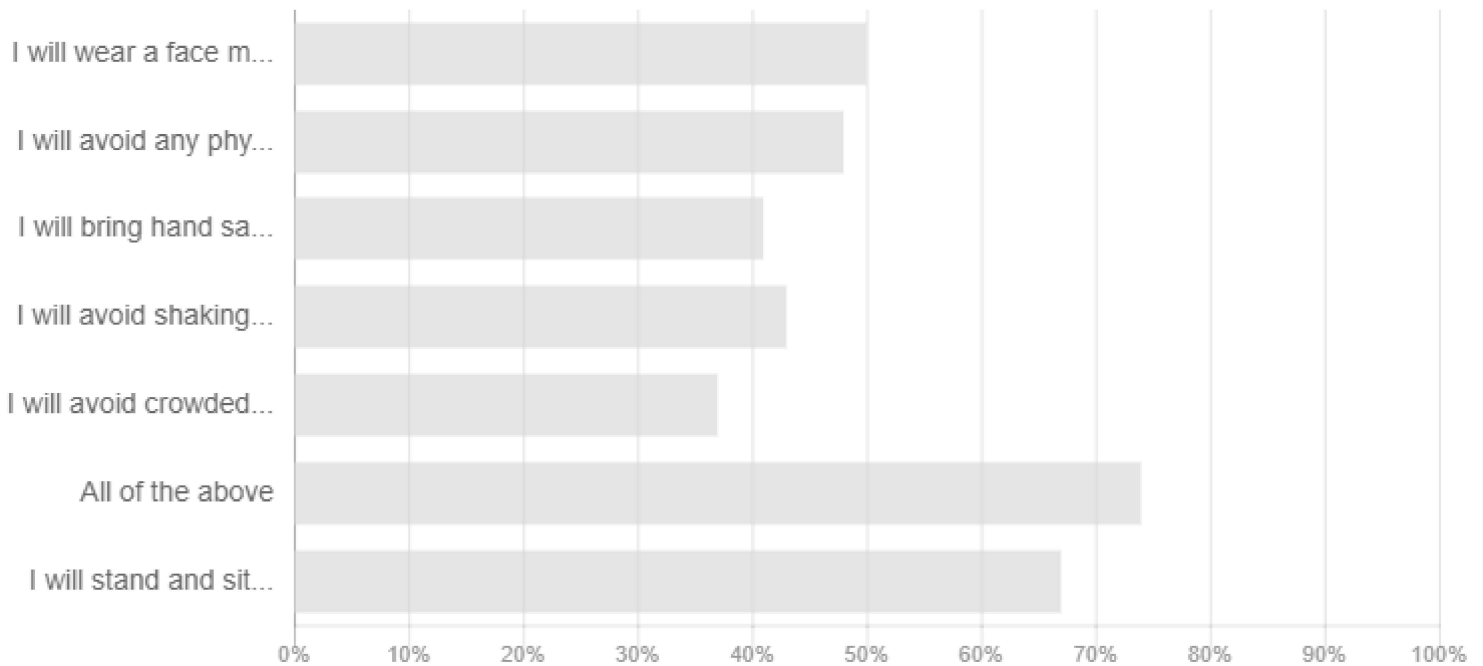

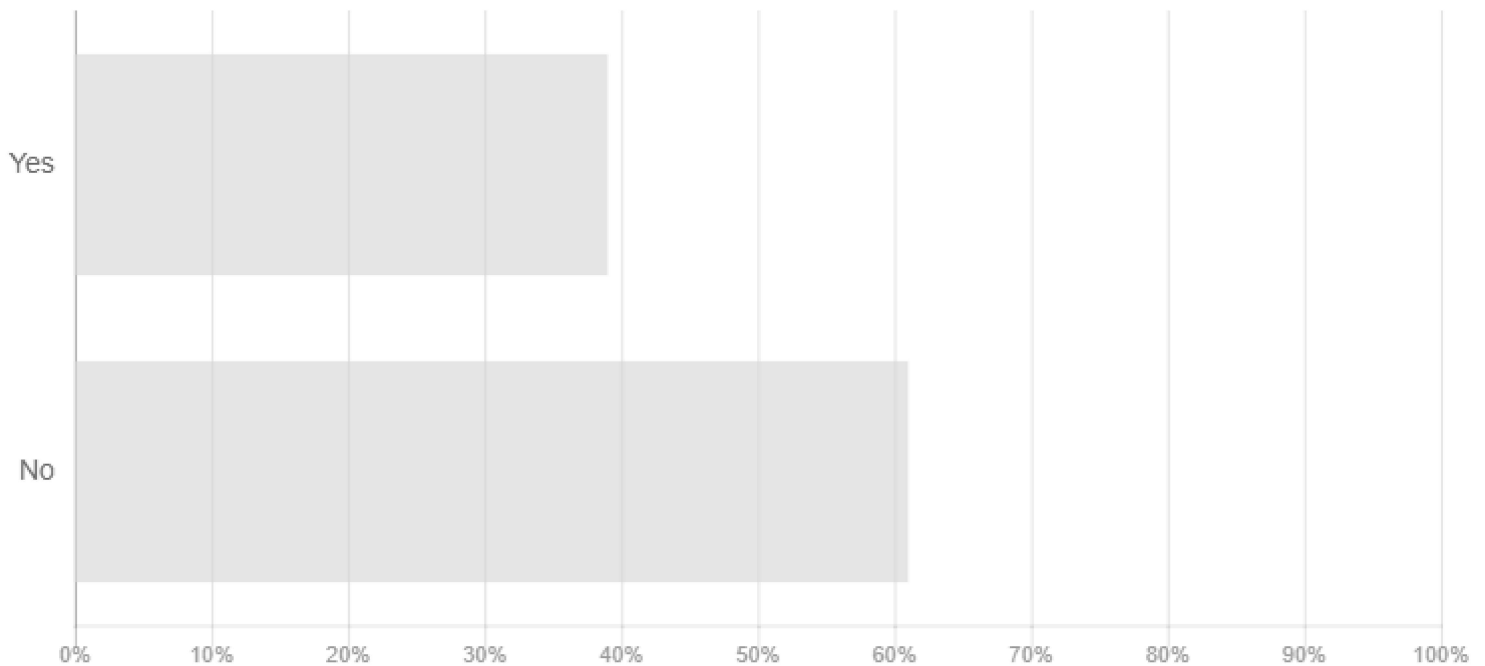

#5 - Do you have children age 18 or younger who typically attend church with you?



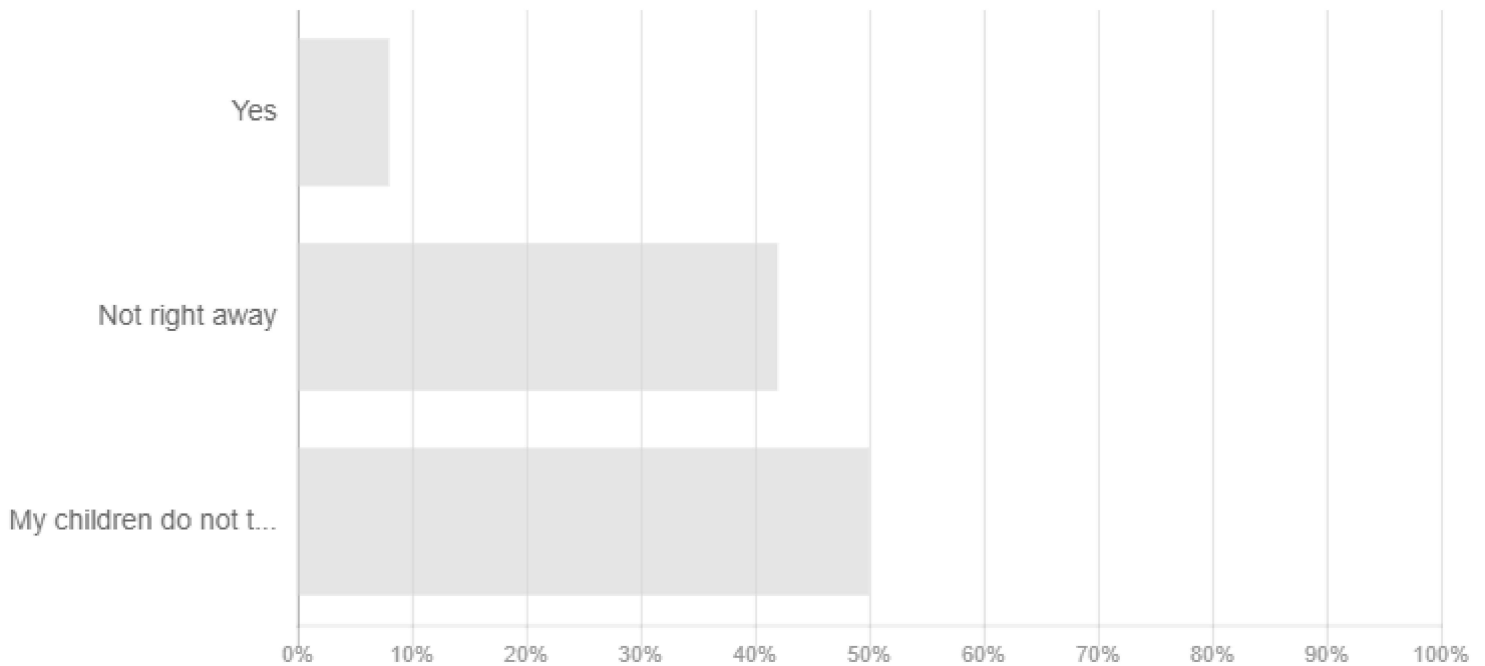

#6 - Would you allow your child(ren) to attend their Sunday morning or Wednesday night program?



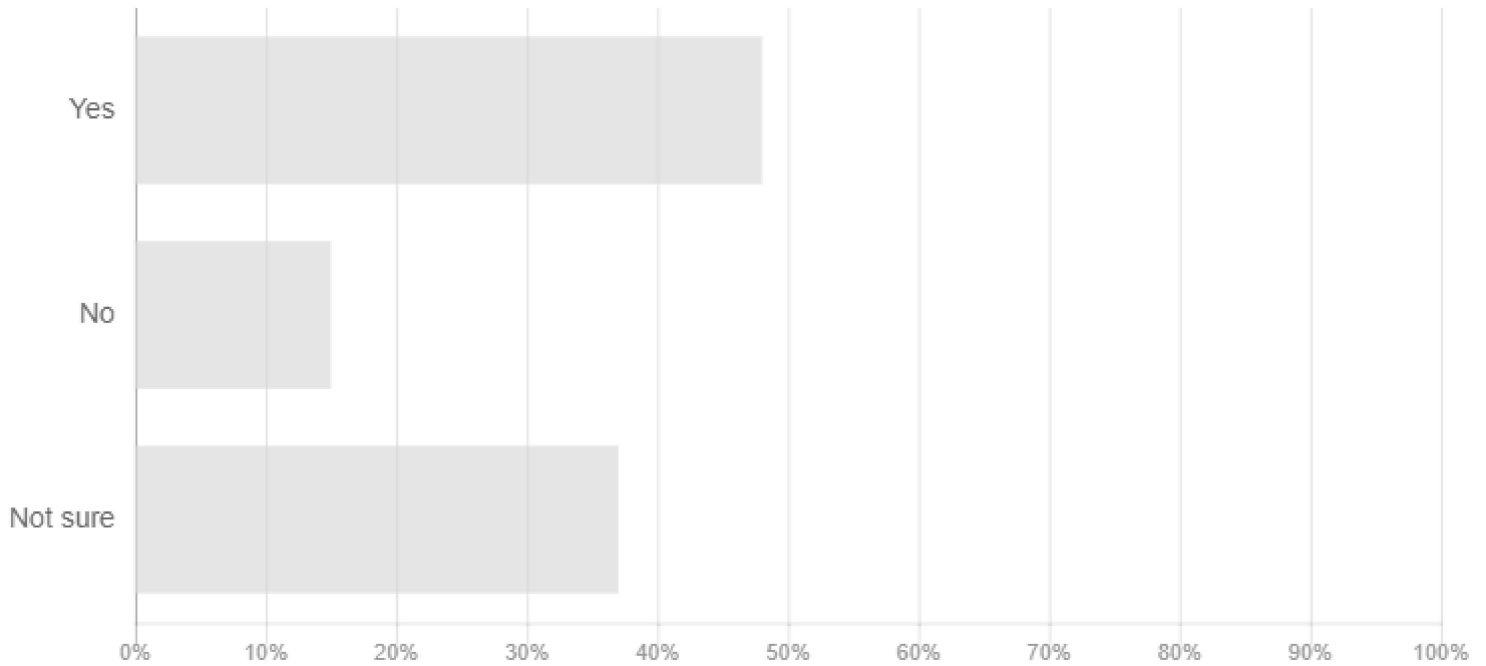

#7 - Would you be willing to attend a worship service in the fellowship hall to ensure people (in the Worship Area and Library) are spread out?



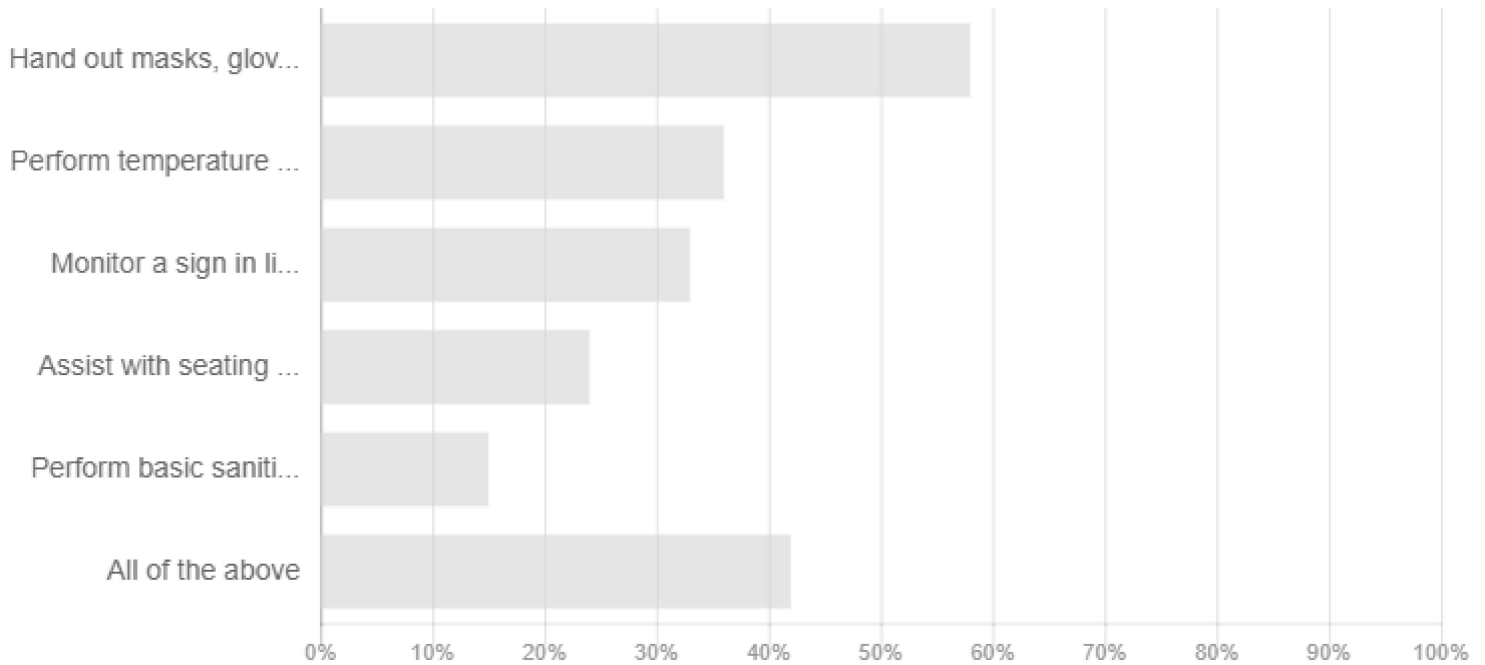

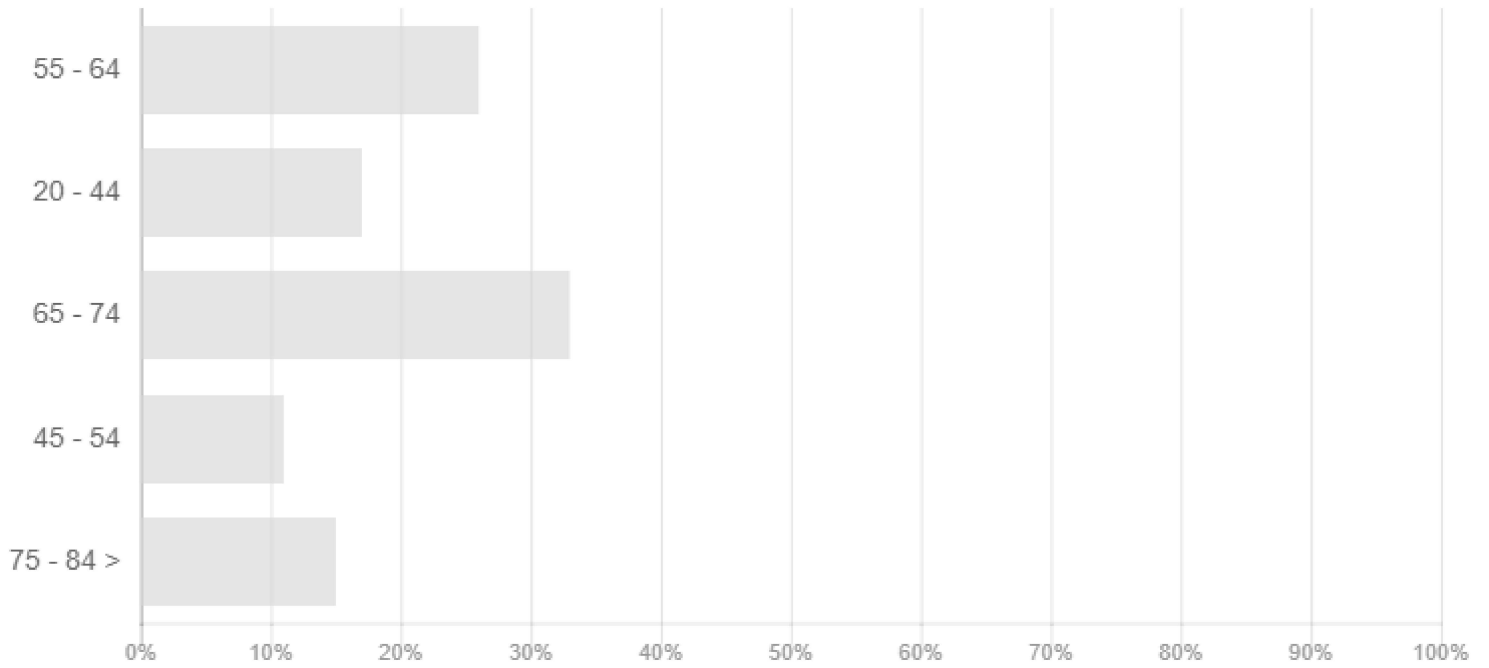
